Objective:

Duration:

This MOU shall be effective as of the date first above written and shall remain in force, unless terminated as stated under "Termination".

Termination:

Either party may terminate this MOU by providing written notice to the other party at least 30 days before the intended termination date.

Amendments:

Any amendments to this MOU shall be in writing and signed by both Parties.

Governing Law:

This MOU shall be governed by and construed in accordance with the laws of the state of Florida.
